General Comments

- Through this reporting period, Wyoming State Treasurer's Office has committed a total of \$1,608,232,620 to 13 non-marketable alternative investments.
- The average age of active investments (based upon vintage year and weighted by commitment) was 6.76 years.
- A total of \$1,785,403,355 has been called or otherwise contributed to date.
- Distributions have totaled \$1,275,500,808 since plan inception.
- The residual estimated value of interests in these partnerships/investments is \$1,199,385,308.
- Since inception net performance for the investments are as follows:
 - Annualized since-inception estimated Internal Rate of Return (IRR) of 11.49%.
 - Were an investment into the benchmark index (S&P 500 Index (Cap Wtd)) ("Index IRR") made with the identical cash-flow pattern, the resulting return would be equal to 10.57% indicating roughly 91 basis points of annualized out-performance.
 - For every \$1 paid into the portfolio, \$1.39 has been returned as a distribution or is held in residual value (multiple on invested capital = 1.39x).

Hedge Funds - Opportunistic

- Hedge Funds - Opportunistic funds account for 27.98% of commitments, 25.20% of contributed funds, 22.62% of distributed funds, and 23.75% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 8.93%
 - S&P 500 Index (Cap Wtd) IRR of 12.80%
 - A multiple on invested capital of 1.27x.

Private Equity - Multi-Stage

- Private Equity - Multi-Stage funds account for 40.91% of commitments, 50.89% of contributed funds, 57.48% of distributed funds, and 51.15% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 13.33%
 - S&P 500 Index (Cap Wtd) IRR of 8.54%
 - A multiple on invested capital of 1.48x.

Private Equity - Venture

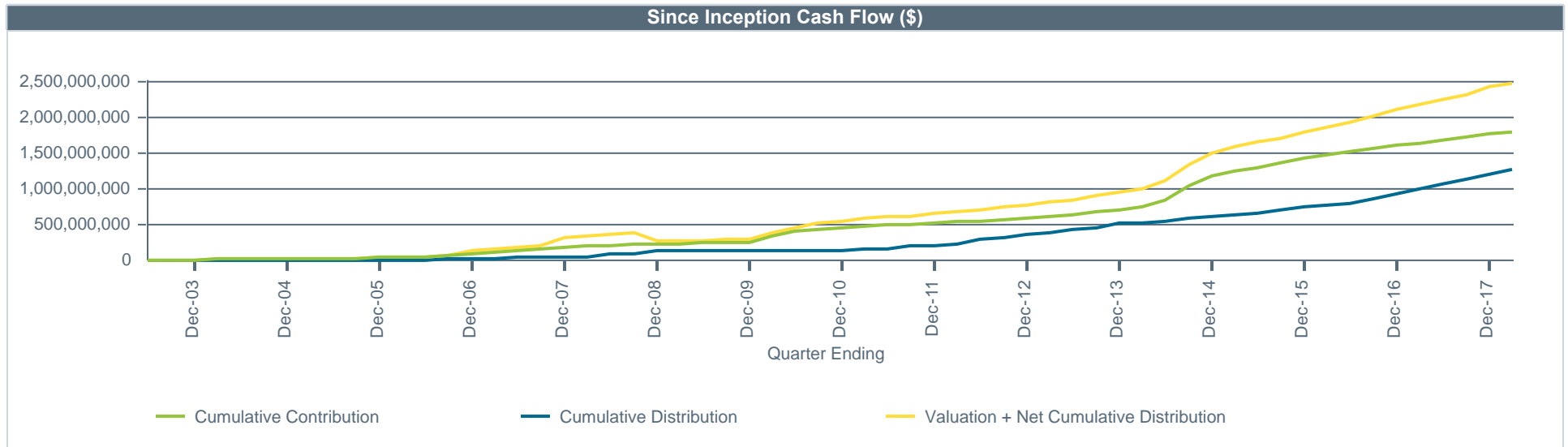
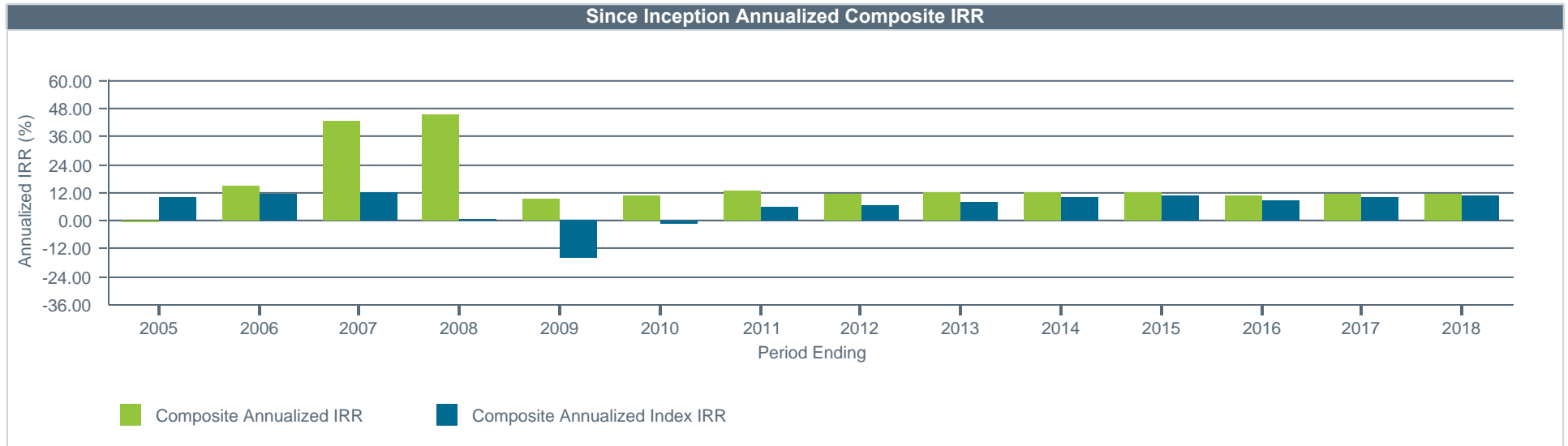
- Private Equity - Venture funds account for 0.62% of commitments, 0.56% of contributed funds, 0.39% of distributed funds, and 1.28% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 11.14%
 - S&P 500 Index (Cap Wtd) IRR of 13.45%
 - A multiple on invested capital of 2.03x.

Real Estate - Opportunistic

- Real Estate - Opportunistic funds account for 9.33% of commitments, 8.37% of contributed funds, 5.28% of distributed funds, and 11.48% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 14.69%
 - S&P 500 Index (Cap Wtd) IRR of 11.17%
 - A multiple on invested capital of 1.37x.

Real Estate - Value Added

- Real Estate - Value Added funds account for 21.16% of commitments, 14.97% of contributed funds, 14.23% of distributed funds, and 12.33% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 6.78%
 - S&P 500 Index (Cap Wtd) IRR of 12.58%
 - A multiple on invested capital of 1.23x.

Non-recallable return of capital distributions are included in Distribution - Gain/Income as they do not reduce the remaining fund commitment. Paid In Capital is adjusted for closing true-ups and closing fee remittances. Grosvenor Global Recovery Fund paid its final distribution in June 2015.
