Wyoming State Treasurer's Office Executive Summary

General Comments

- Through this reporting period, Wyoming State Treasurer's Office has committed a total of \$2,180,290,720 to 17 non-marketable alternative investments.
- The average age of active investments (based upon vintage year and weighted by commitment) was 7.22 years.
- A total of \$2,249,139,100 has been called or otherwise contributed to date.
- Distributions have totaled \$2,066,505,761 since plan inception.
- The residual estimated value of interests in these partnerships/investments is \$1,206,062,555.
- Since inception net performance for the investments are as follows:
 - Annualized since-inception estimated Internal Rate of Return (IRR) of 11.49%.
 - Were an investment into the benchmark index (S&P 500 Index (Cap Wtd)) ("Index IRR") made with the identical cash-flow pattern, the resulting return would be equal to 11.70% indicating roughly -22 basis points of annualized out-performance.
 - For every \$1 paid into the portfolio, \$1.46 has been returned as a distribution or is held in residual value (multiple on invested capital = 1.46x).

Hedge Funds - Opportunistic

- Hedge Funds Opportunistic funds account for 20.64% of commitments, 20.01% of contributed funds, 25.74% of distributed funds, and 4.43% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 7.76%
 - o S&P 500 Index (Cap Wtd) IRR of 13.26%
 - A multiple on invested capital of 1.30x.

Private Equity - Buyout

- Private Equity Buyout funds account for 17.20% of commitments, 5.23% of contributed funds, 0.00% of distributed funds, and 10.37% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 5.75%
 - S&P 500 Index (Cap Wtd) IRR of 22.32%
 - A multiple on invested capital of 1.06x.

Private Equity - Growth Equity

- Private Equity Growth Equity funds account for 2.29% of commitments, 0.79% of contributed funds, 0.00% of distributed funds, and 1.69% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR Not Material
 - O S&P 500 Index (Cap Wtd) IRR Not Material
 - A multiple on invested capital of 1.14x.

Private Equity - Multi-Stage

- Private Equity Multi-Stage funds account for 30.18% of commitments, 43.64% of contributed funds, 53.07% of distributed funds, and 46.16% of reported residual value.
- Pooled portfolio since inception performance is as follows:
 - Annualized since-inception IRR of 13.75%
 - S&P 500 Index (Cap Wtd) IRR of 9.46%
 - A multiple on invested capital of 1.68x.




