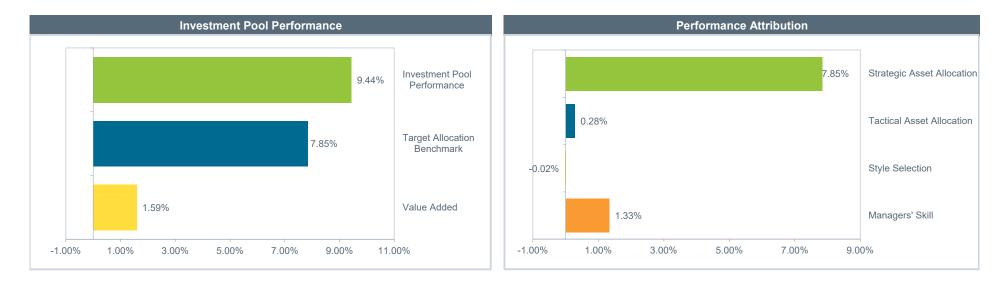

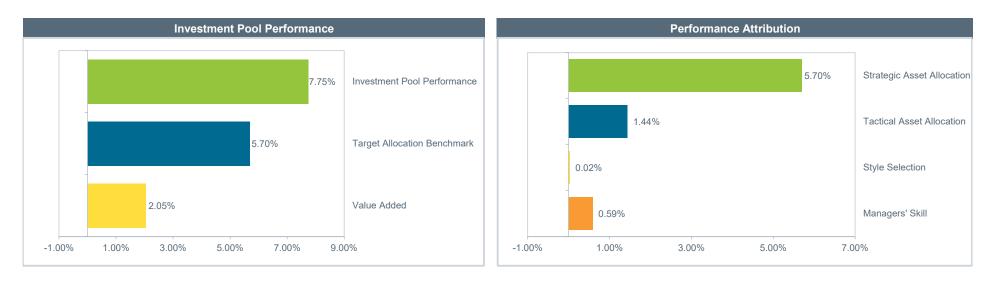

Wyoming State Treasurer's Office Pool Attribution - IDP Methodology Pool A vs. Target Allocation Index FYTD Ending March 31, 2024



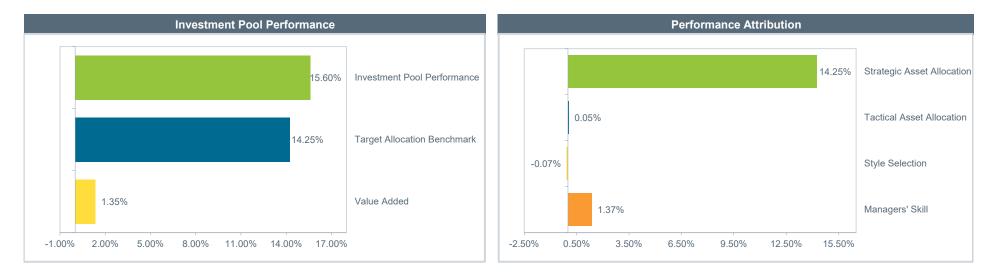


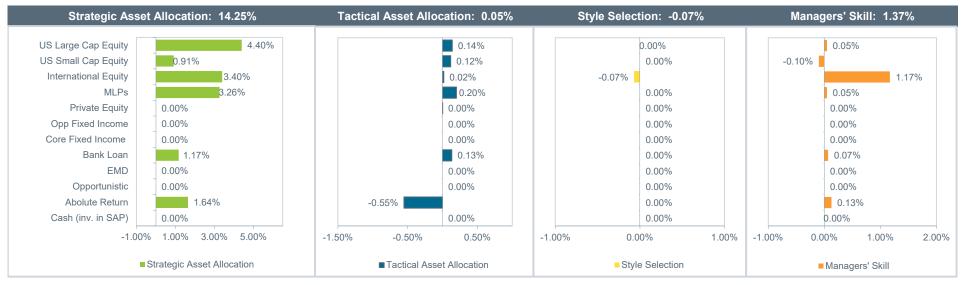

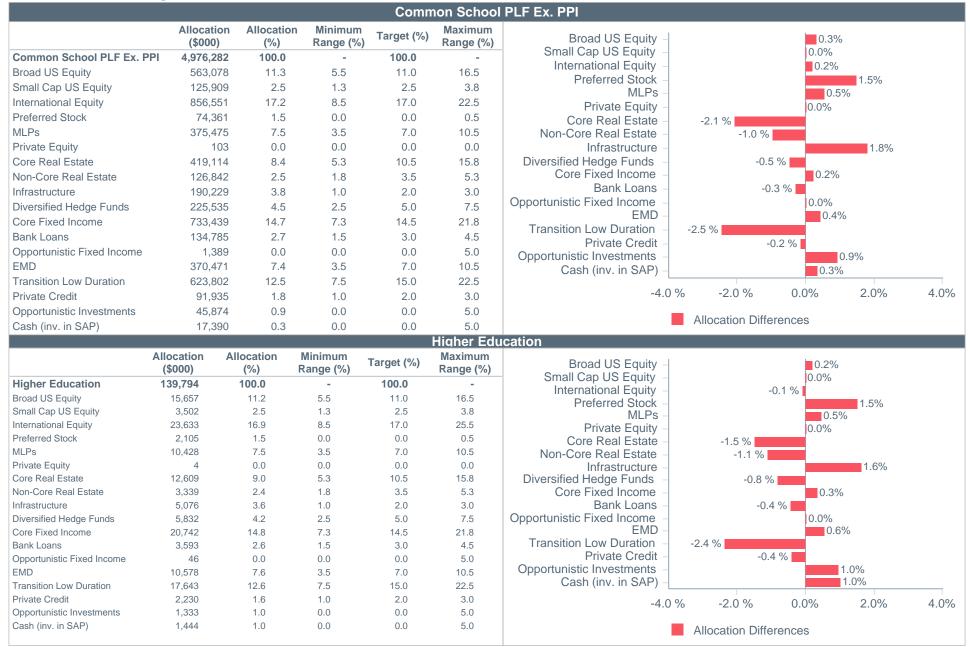
Wyoming State Treasurer's Office Permanent Funds - Total Return Focus Asset Allocation vs. Target

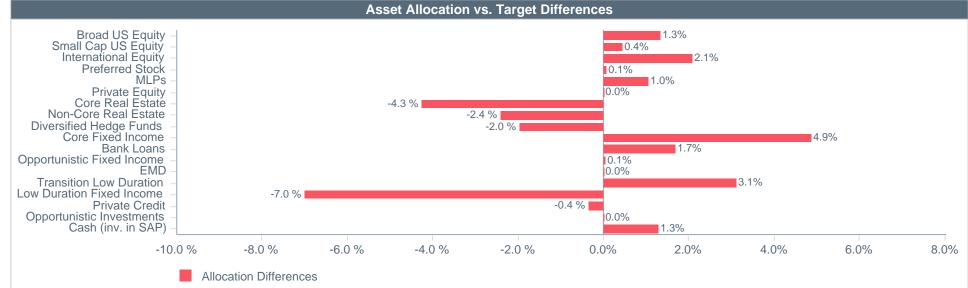

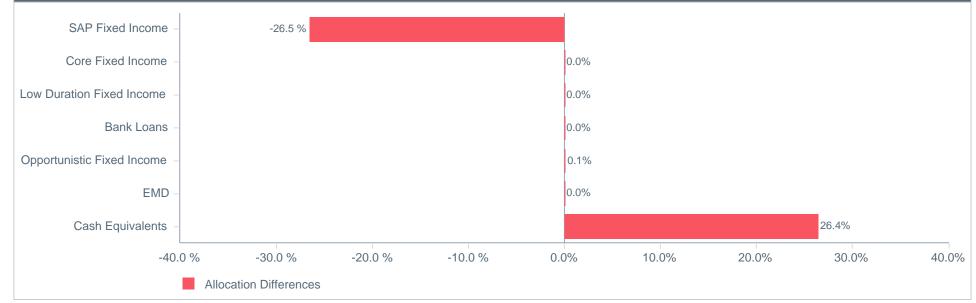
