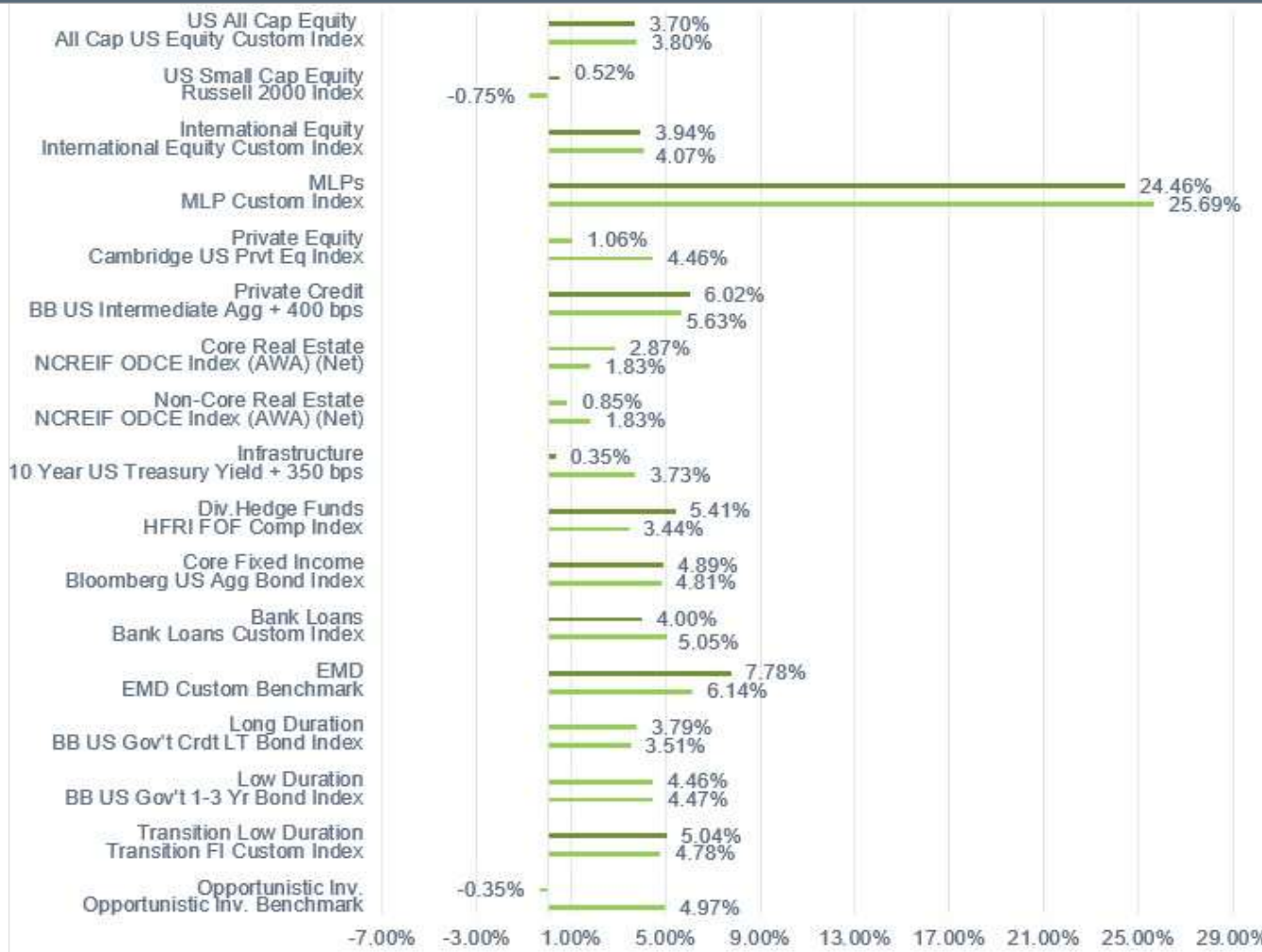

FYTD Ending March 31, 2025**

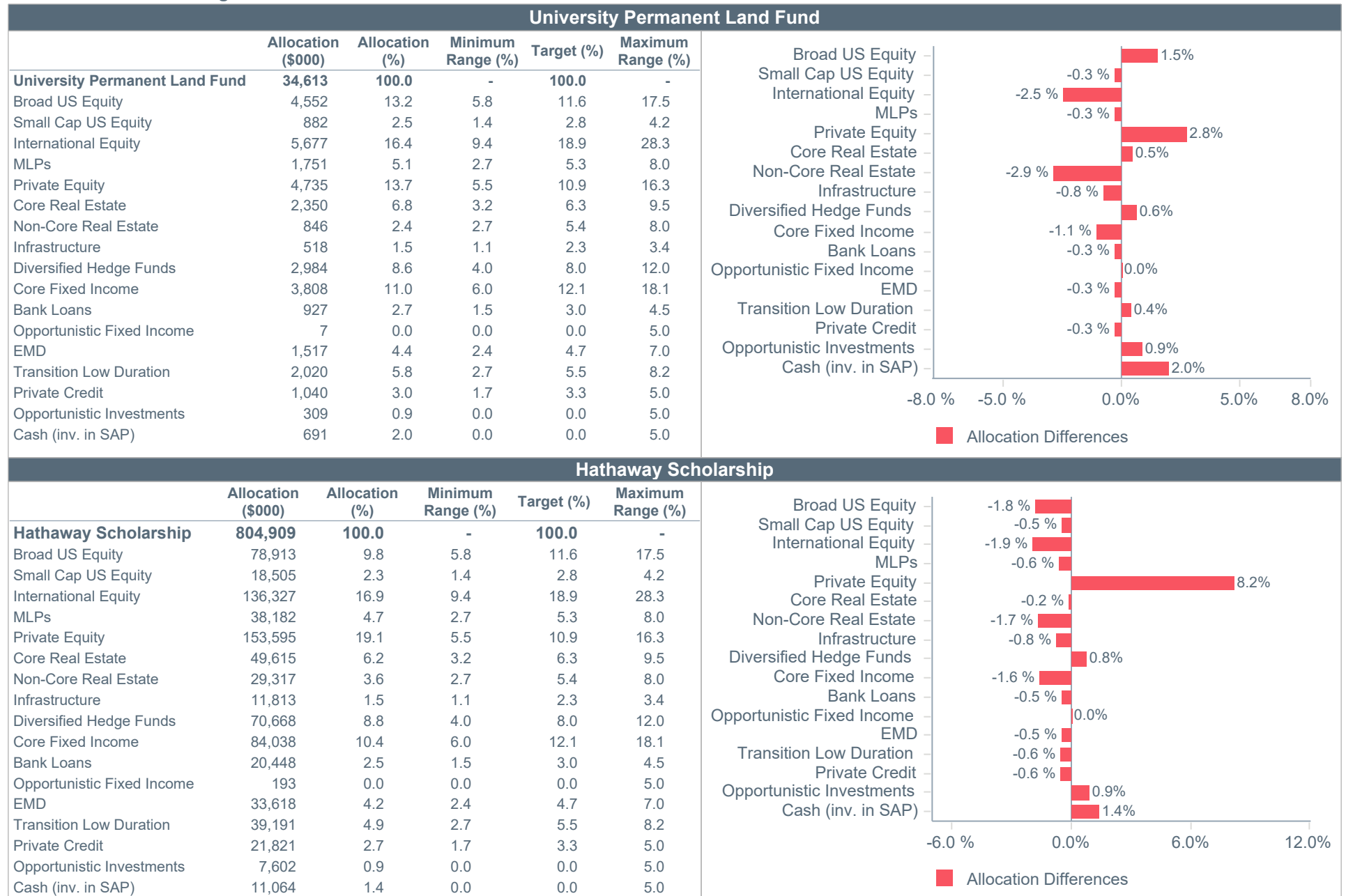

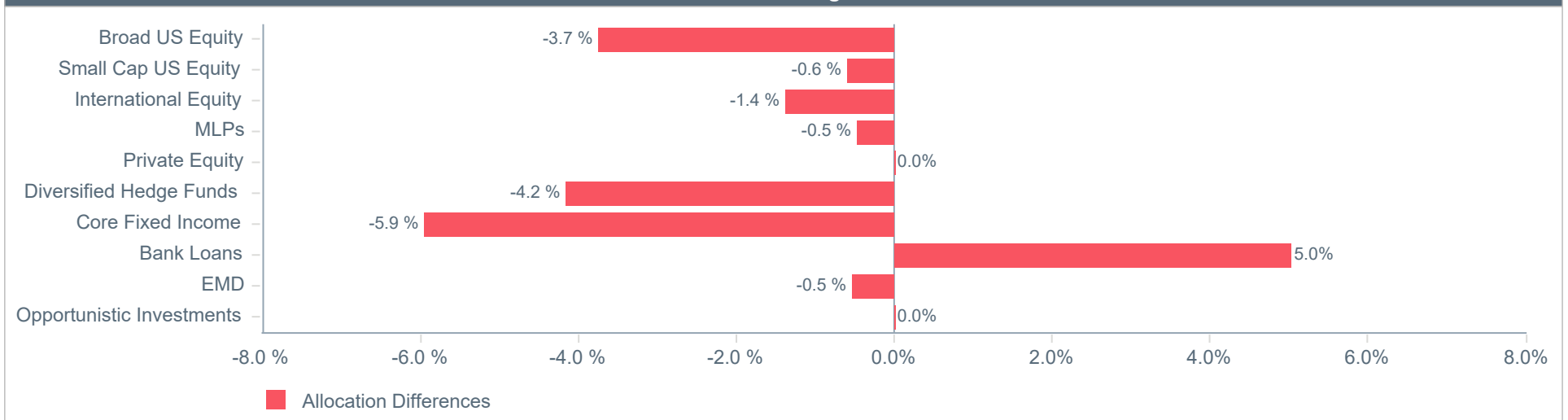

Asset Allocation vs. Target Differences

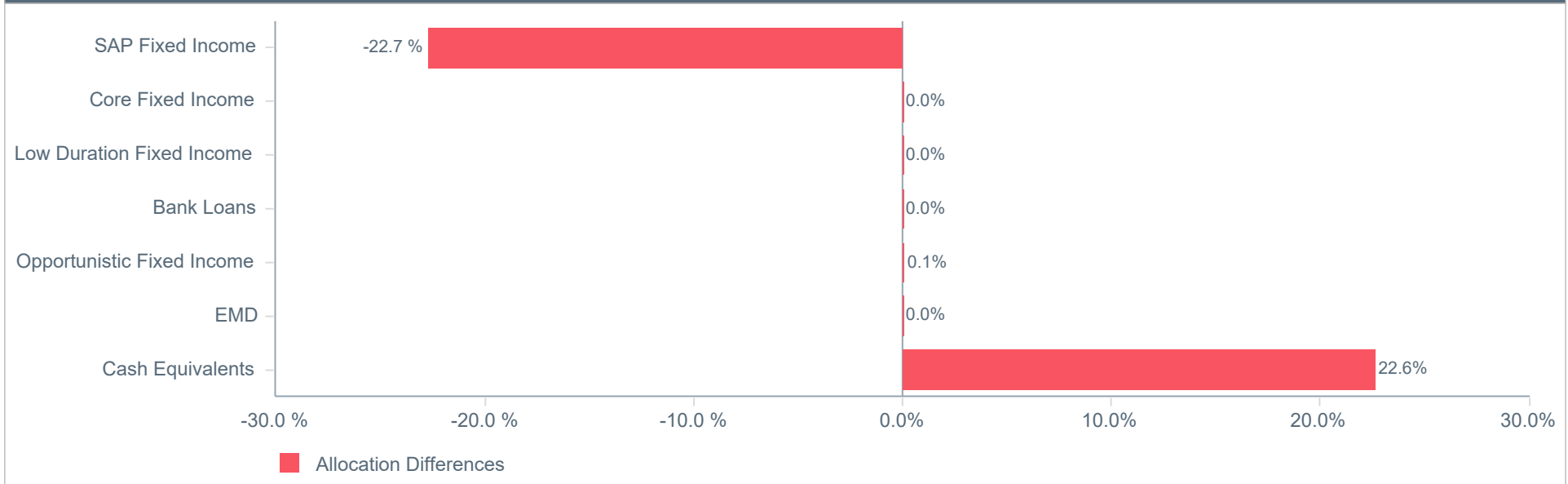
